Dear Mr. Burgheimer:

We represent McDonald's Corporation. We have recently been made aware of the webpage at http://www.down10.com/fonts/mclawsuit. This webpage is titled "McLawsuits" and identifies you as the owner of the webpage contents. (See enclosed copy.) The WHOIS database at www.networksolutions.com lists you as the administrative contact and Telocity.com as the Internet Service Provider for the website. We are copying the Internet Service Provider on this correspondence.

While we applaud your efforts to create novel fonts that may be shared and used by others over the Internet, your comments on your webpage show that you can appreciate the concern and objection our client has to the use of the "McLawsuit" font. Unfortunately, McDonald's cannot support the pursuit of artistic and creative endeavors at the expense of permitting the unauthorized use of its intellectual property in the manner as depicted on your webpage. Although your webpage states that the "McLawsuit" font is not based on the "Golden Arches" logo, this assertion is untenable in view of the content of your website and your unmistakable use of and reference to the "Golden Arches" and McDonald's Corporation. Most notably, based on the content and font that you created, you expressed concern that McDonald's would "slap me with some McCease and Desist order."

Your unauthorized use and display of McDonald's Corporation's famous "Golden Arches" logo and "Super Size" registered trademarks and use of the word "McLawsuit" and red and gold design (as depicted on your webpage) infringe McDonald's Corporation's trademark and trade dress rights under U.S. federal and common law. Through McDonald's Corporation's

extensive use of the "Mc" prefix, the public has come to recognize this prefix and associate it with McDonald's Corporation and its goods and services. Thus, your website's use of the term "McLawsuit" poses a problem for our client.

We are particularly concerned with your unauthorized use and display of McDonald's Corporation's "Golden Arches" logo as a font. Except as the "Golden Arches" logo is incorporated in the "McDonald's" mark and its "McKids" mark, McDonald's Corporation does not use, nor does it permit others to use the "Golden Arches" logo as a letter in the alphabet or as any other symbol.

Your website infringes McDonald's intellectual property rights in several respects. The "M" in "McLawsuit" is an identical facsimile of the famous "Golden Arches" logo; the use of the "Mc" prefix in "McLawsuit" infringes McDonald's "Mc" family of marks; the selection and use of colors (red and gold) copies the famous trade dress that distinguish McDonald's products and services and the numerous references on your website to McDonald's Corporation all clearly associate your website with McDonald's Corporation. Based on such use of identical or confusingly similar trademarks on your webpage, McDonald's is concerned that your webpage will dilute the distinctiveness of its famous marks.

Based on the foregoing, we must request that you immediately cease and desist all use and remove from your website the "Golden Arches" logo and any derivative of this design, the "Super Size" reference, any "Mc" prefix and any other material, including, trademarks, trade dress, logos, and copyrighted materials that infringe the intellectual property rights of McDonald's Corporation.

As you acknowledge on your website, McDonald's Corporation has taken vigorous legal action in the past to enjoin unauthorized uses of its trademarks, trade dress and logos and has been very successful in protecting its rights. Although McDonald's Corporation prefers an amicable resolution of this matter, if necessary, it will take further action to protect its rights and goodwill.


